The Board has continued to be successful in resolution of complaints. The Board has experienced litigation that was successful resolved during the last year.

The Board and industry continue to discuss the change in scope of practice to allow a podiatrist to practice above the foot to include the ankle area. Alabama is 1 of 2 states in the United States that does not allow its licensees this privilege. This is extremely important with recruiting new licensees to come to Alabama to practice Podiatry. Most graduates choose their practice locations based on this one privilege. We are not growing in licensees and do see this as a significant issue in the near future.

The Board continues to operate through a Special Fund Account with a balance of \$30,150.08 as of December 30, 2018. Board revenue consists of license fees, license renewal fees, examination fees, administrative fines and/or penalties. The Board currently has 156 licensed podiatrists.
